Scenario

Kathy's LLC has the role of **Borrower** on a Commercial Loan, for which Jones Guarantor LLC has the role of **Guarantor**. Emily Jones is acting as Borrower Authorized Signer on behalf of Kathy's LLC, Guarantor Authorized Signer on behalf of Jones Guarantor LLC, and Resolving Party Authorized Signer on behalf of Kathy's LLC. The title listed in the signature block needs to be different for each signature instance. All required general information and transaction information data has already been entered for Jones Guarantor LLC and Kathy's LLC prior to beginning this job aid.






Procedure

1- Emily Jones has already been assigned the role of **Borrower Authorized Signer** for Kathy's LLC. The *Missing Roles* subtab in the *Entities* pane indicates that there are two roles that need to be assigned to entities based on the transaction scenario: **Guarantor Authorized Signer** and **Resolving Party Authorized Signer**.




2- According to the Entities and Roles table at the beginning of this job aid, Emily Jones needs to have a different title listed for each role she fulfills in the transaction. To accomplish this, we will need to make a separate iteration of Emily Jones for each title. From the *Missing Roles* subtab, we will select *Add to new Entity* a new entity for the role of **Guarantor Authorized Signer**.






4- Next, we need to enter Emily Jones in the full name field, link her to Jones Guarantor, and click the "Add" button.




5- Now we can follow the same steps for the role of **Resolving Party Authorized Signer**. We'll navigate to the *Missing Roles* subtab in the entities pane and select *Add to new Entity* for the missing role of **Resolving Party Authorized Signer**. Then, we'll enter Emily Jones in the full name field, and check the box next to Kathy's LLC to link the new iteration of Emily Jones to the appropriate resolving party.






6- There will now be three iterations of Emily Jones listed on the *Entities* pane.




7- Now, we can add the job titles for each iteration of Emily Jones. First, we'll navigate to the *Entities* tab and select the *General Information* subtab for the first iteration of Emily Jones, where she is assigned the role of **Borrower Authorized Signer**. Here, we can select "Add job title" and enter *President* in the job title field.





8- Next, we need to navigate to the second iteration of Emily Jones, who is assigned the role of **Guarantor Authorized Signer**, and enter her title. According to the entities and roles section at the beginning of this job aid, her title needs to be Managing Member.



9- In order to add a title for Emily Jones in her role as **Resolving Party Authorized Signer**, we need to navigate to the *Resolutions* tab in Runtime. Then, we need to select the *Authorized Signer* subtab under *Resolving Party*. According to the entities and roles section of this job aid, her title should be CEO.



Note: The Authorized Signer subtab will not be visible in the Resolving Party section on the Resolutions tab until all required data on the Certifying Information subtab has been completed.



10- Once all remaining required data has been completed in the workflow, the signature section for the Guaranty, the Resolution, and the Note will appear as follows.
